Rifles Allowed: Service Rifle-Rule 3.1; Match Rifle-Rule 3.3; Any Sight Match Rifle Rule 3.3.2

Awards: Awards will be made for each individual/team match according to NRA classes. Three competitors are required to establish an NRA class for each category.

Saturday

- MATCH 1 200 yards standing slow fire, 2 sighters and 20 shots for record. NRA rule 5.12. (22 minutes time limit, NRA Rule 8.2a) SR TGT.
- MATCH 2 200 yards rapid fire, sitting or kneeling, 2 sighters and 20 shots for record (two ten shot strings). NRA rule 5.8, 5.10 (time limit per NRA Rule 8.2b) SR TGT.
- MATCH 3 300 yards rapid fire, prone, 2 sighters and 20 shots for record (two ten shot strings). NRA rules 5.6 (Time limit per NRA Rule 8.2b) SR3 TGT.
- MATCH 4 600 yards prone slow fire, 2 sighters and 20 shots for record. NRA Rule 5.6. (22 minutes time limit, NRA Rule 8.2a) MR1 TGT.
- MATCH 5 Aggregate of matches 1, 2, 3, 4.

Sunday

- MATCH 6 200 yards standing slow fire, 2 sighters and 20 shots for record. NRA rule 5.12. (22 minutes time limit, NRA Rule 8.2a) SR TGT.
- MATCH 7 200 yards rapid fire, sitting or kneeling, 2 sighters and 20 shots for record (two ten shot strings). NRA rule 5.8, 5.10 (time limit per NRA Rule 8.2b) SR TGT.
- MATCH 8 300 yards rapid fire, prone, 2 sighters and 20 shots for record (two ten shot strings). NRA rules 5.6 (Time limit per NRA Rule 8.2b) SR3 TGT.
- MATCH 9 600 yards prone slow fire, 2 sighters and 20 shots for record. NRA Rule 5.6. (22 minutes time limit, NRA Rule 8.2a) MR1 TGT.
- MATCH 10 Aggregate of matches 6, 7, 8, 9.
- MATCH 11 Grand Aggregate of matches 5 and 10.
